#### VIII. Addenda

A. Public Comment: Springer – handed out flyers regarding SEL – against all SEL screening in this school. She is a parent of an HHS student. SEL tool is liberal social engineering / inclusion agenda from MDE leading to a path of conformity. No screener can replace human interaction; urge you to vote against SEL screening at all. Riley discussed SEL.

Novak - \$470,000 grant for 10 years — unending \$; No cost screener, they will want more. You all mean well (School Board) — what can become of the screener? Inviting outside elements into our children's lives. If there are needs not being met — find another way- Hillsdale Co. needs to take care of Hillsdale Co. SEL screener is a bad decision — judgement to stop it if you can.

B. Board Comment: Portteus – Teachers/ Admin. take care of the students (out of the box) – students will benefit from the screener tool – mental health

Bowen – HCS does not get any money from the SEL eval tool. Parents have a choice to take ISD services.

Bennett-Granata – SEL formal presentation – teachers refer and services are rendered if parents choose to have the services. These are concerns, not a diagnosis. Mental health has always been an issue, even more so after COVID. We want the resources available, parents can decline. The HCISD millage not passing is devastating as general fund pays so much of the special education budget.

Riley – Gov. and community – fallacy – Word to Wise – solutions that appear to be free – historically have Gov. objectives.

Springer – 31N grant already approved – screener is not needed? Vondra responded that HCISD allowed services this year temporarily – have to make progress – implementation of universal screener tool from here on out.
